- Our resolution was defeated on convention floor, after over 30 minutes of discussion
- Our council won 2 awards, and was the runner up on 2 others. We won awards for Community Activities and Support of Life. We were runners up in Public Relations and Church Activities
- We had 6 regional winners in the basketball free-throw
- The 2015 convention will be in Prince Albert
- Our total contributions to the charitable foundation is now \$35,003
